## Maintenance Technician/Trainee

### Description

This is a full-time entry level maintenance position for a maintenance tech or trainee. The HRA is looking for a self-motivated person who is thorough, reliable, mechanically inclined, can problem solve, can work well independently and as a member of a team, has the ability to work well with a diverse population and a strong interest in customer service. Prior housing experience is a plus.

### Duties and responsibilities

#### Maintenance Technician

Performs custodial/janitorial work.

1. Performs required tasks to maintain buildings and grounds in a safe and sanitary condition.
2. Conduct daily inspections of assigned building, grounds and equipment; identify and report any repairs or hazards.
3. Perform routine maintenance and repairs as directed.
4. Assist in the preparation of units for re-rental.
5. Document and respond to service calls as assigned.
6. Maintain grounds throughout seasonal changes: lawn care, landscaping and snow/ice removal.
7. If assigned, monitor boiler operations per state regulations. Perform needed boiler repairs and adjustments immediately.

Develops and maintains effective working relationships.

1. Develops and maintains good working relationships with HRA staff, residents and the public.
2. Explains procedures, respond to inquiries and assists in resolving issues, complaints and/or refers to appropriate staff.

Performs other duties as assigned.

#### Maintenance Trainee

Performs custodial and assists with routine maintenance work.

1. Performs required tasks to maintain buildings and grounds in a safe and sanitary condition including all necessary cleaning tasks.
2. Conduct daily inspections of assigned building, grounds and equipment; identify and report any repairs or hazards.
3. Assist in maintaining, cleaning, and repairing equipment using all appropriate safety procedures.
4. Assist in performing routine maintenance and repairs as directed.
5. Assist in the preparation of units for re-rental.
6. Document and respond to service calls as assigned.
7. Maintain grounds throughout seasonal changes: lawn care, landscaping and snow/ice removal.
8. Assist with monitoring boiler operations per state regulations. Assist in performing needed boiler repairs and adjustments.

**Education and work experience required:  
Maintenance Technician**

1. High School graduate or GED; and
2. One year work experience in a related field; or
3. Any combination of education and/or work experience as may be

acceptable by the Executive Director.

### **Maintenance Trainee**

1. High School graduate or GED; and
2. Positive work history or references; or
3. Any combination of education and/or work experience as may be acceptable by the Executive Director.

### **Physical Requirements:**

#### **Maintenance Technician and Trainee**

1. Must be able to physically perform the basic life operational functions of climbing, stooping, kneeling, crouching, reaching, walking, pulling, lifting, fingering, grasping, talking, hearing, and performing repetitive motions.
2. Must be able to perform heavy work exerting 100 pounds of force occasionally, 50 pounds frequently, and 20 pounds constantly.
3. Must be able to possess the visual acuity to read and prepare reports, and view a computer terminal.
4. Persons with mental or physical disabilities are eligible for this position as long as they can perform the essential functions of the job after reasonable accommodation is made to their known limitations. If the accommodation cannot be made, because it would cause the employer undue hardship, such person may not be eligible.

### **License /Certification:**

#### **Maintenance Technician**

Valid Driver's License is required. Employees assigned to monitor boiler operations must have or obtain within the specified period of time and thereafter maintain the operating license designated by management.

#### **Maintenance Trainee**

Valid Driver's License is required.

### **Wages and benefits:**

The HRA offers a competitive wage starting at \$21.08/hr for Maintenance Technician and \$17.77/hr for Maintenance Trainee. The benefit package, in the current contract, includes health, dental, flexible spending plan, life insurance, long term disability insurance, vacation, holiday, personal, and sick leave, as well as an employer paid retirement plan.
